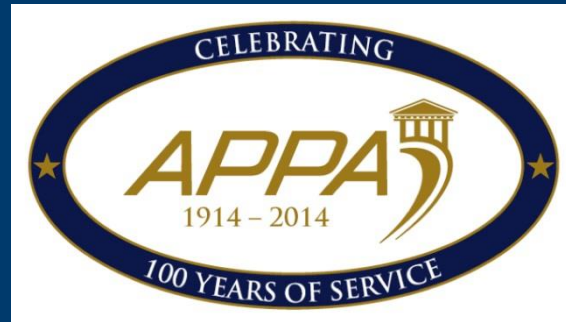

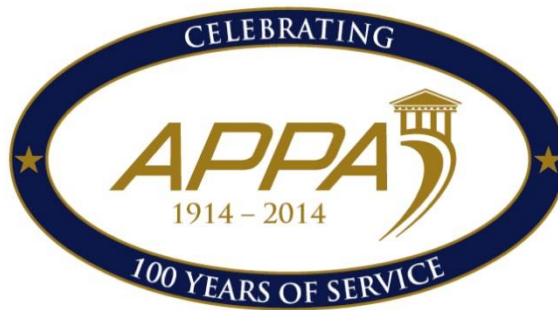

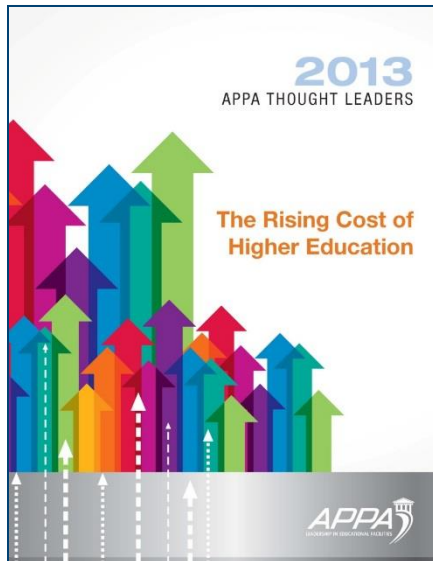

Demonstrates that the facilities organization contains qualified professionals.

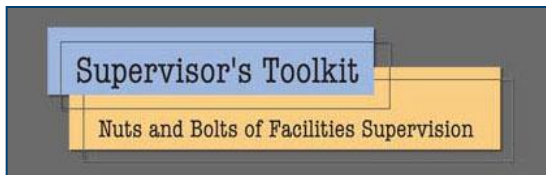

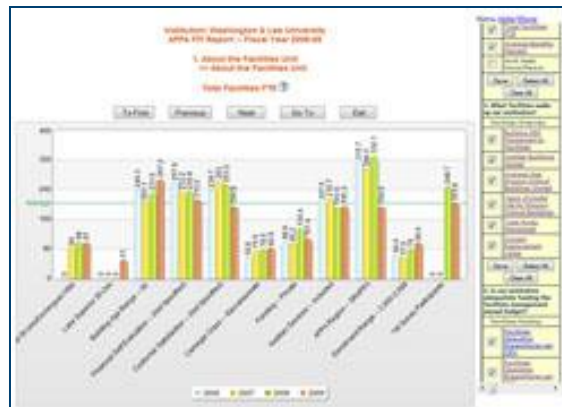

The Council Mission

- ***Promote codes and standards awareness*** among member institutions.
- ***Determine impacts*** of existing codes and proposed standards.
- ***Influence*** codes and standards development and outcomes.
- ***Display APPA's Leadership*** in standards and codes, seek pragmatic solutions.
- ***Identify broad consensus among APPA members*** on standards and codes issues, seek appropriate representation within standards bodies.



Construction Codes Tracked by APPA

While any code, regulation, or standard can impact the design and construction of a building, most of the impact will fall under one of the following major model code documents:



- **National Fire Protection Association (NFPA)**

- NFPA 101 (Life Safety Code)
- NFPA 13 (Sprinklers)
- NFPA 70 (National Electrical Code)
- NFPA 72 (Fire Alarm Systems)



- **International Code Council (ICC)**

- IBC (International Building Code)
- IMC (International Mechanical Code)
- IPC (International Plumbing Code)
- IECC (International Energy Conservation Code)

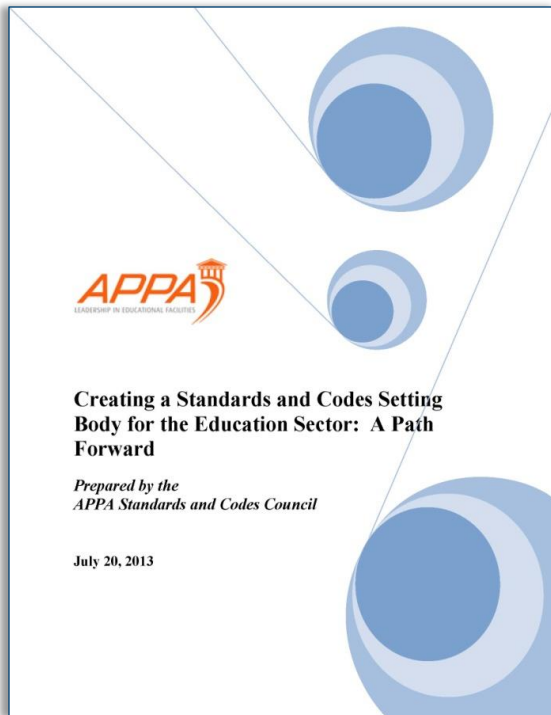


Construction Codes Tracked by APPA



- **American Society of Heating, Refrigerating, and Air Conditioning Engineers (ASHRAE)**
 - ASHRAE 90.1 – Energy Standard for Buildings Except Low-Rise Residential Buildings
 - ASHRAE 90.2 – Energy Efficient Design of Low Rise Residential Buildings
 - ASHRAE 189.1 – Standards for the Design of High Performance Green Buildings Except Low-Rise Residential Buildings
 - ASHRAE 189.3 – Design Construction and Operation of Sustainable High Performance Health Care Facilities

APPA Standards and Codes Council



- Scope of work approved by the Council.
- Propose draft contributions for consideration and/or adoption in proposed and existing standards.
- **May create and publish APPA Standards**, technical reports, requirements and best practices germane to the needs of the education sector.

Council Work Groups (as of 5/7/2014)



Green Codes Work Group – Evaluating the impact of the International Green Construction Code (IgCC) and ASHRAE 189.1 on education.

- IgCC and ASHRAE 189.1 define sustainability requirements for construction, operations and maintenance of the building and land parcel.

Council Work Groups (as of 5/7/2014)



Cleaning Standards Work Group – Addressed ANSI Standards Activity proposed by the Simon Institute/ManageMen Inc.

- Report and findings available at www.appa.org
- APPA and International Sanitary Supply Association (ISSA) have filed a joint appeal with ANSI, seeking discontinuation of the Simon Institute's ANSI standards activities.
