Please mail your stock certificate(s) directly to the Office of Development - do not sign the certificate(s). If two names appear on the certificates, the stock power must contain both signatures. Mailing the unsigned stock certificate(s) and the signed stock power form(s) separately helps to prevent theft. We recommend using certified mail/return receipt requested, and retain the date-stamped receipt for your tax records.

Your stock is valued as the average of the high and low prices on the date of transfer - this is the date the stock was electronically transferred to the National Academy of Engineering or the date stamped on the U.S. Postal Service certified mail receipt.
