## *AAFS Promotes Forensic Science Research –*

- Forensic Sciences Foundation is the educational, scientific, and research arm of the AAFS.
- The overall objectives of the Foundation are:  
develop and conduct education and training programs; develop new ways to improve the forensic sciences; promote public education concerning all disciplines in the forensic sciences; and support research in fields relating to the forensic sciences.

# American Academy of Forensic Sciences

## Forensic Science Education Programs

### Accreditation Commission (FEPAC) –

- Maintain and enhance the quality of forensic science education through a formal evaluation and recognition of college-level academic programs.
- Develop and maintain standards and administer an accreditation program that recognizes and distinguishes high quality undergraduate and graduate forensic science programs.

## The Young Forensic Scientists Forum –

- Dedicated to the education, enrichment and development of emerging forensic scientists and future leaders of the field.

## Forensic Science Educational Conference –

# American Academy of Forensic Sciences

## Funding of Resources –

- Crime laboratories and medical examiner/coroner offices are generally under-funded.
- Lack of funding leads to backlogs.
- Although resources have recently targeted DNA backlogs nationwide, laboratories continue to face backlogs in other disciplines such as trace evidence, chemistry and toxicology.
- Funding is needed in all areas (staffing, facilities, equipment, etc.).

# American Academy of Forensic Sciences

## Funding of Education –

- Shortage of qualified forensic scientists at all levels of competency – CSI to Director.
- Training critically needed and required by all forensic science disciplines.
- A limited number of forensic science training programs currently exist including undergraduate, graduate and on-the-job.
- Continuing education is a vital component of forensic science practice.

# American Academy of Forensic Sciences

## Funding of Research –

- Advances the field of forensic science through the development of new methodology.
- Ensures the validity of scientific protocols through quality management.
- Facilitates technology transfer through sharing of information.

# American Academy of Forensic Sciences

## Crime Lab and Homeland Security Missions –

- In many States, there is virtually no connection between crime laboratories, medical examiner/coroner offices and the regional Homeland Security Mission.
- Disaster victim identification by DNA and other means is often times not integrated.
- Crime laboratories who send personnel to crime scenes have little training or expertise in chemical, biological, radiological, nuclear and explosives hazards.

# American Academy of Forensic Sciences

## AAFS Recommends –

- Development of new forensic science public policy including the dissemination of best practices and guidelines.
- Development of a *National Forensic Science Master Plan* which addresses resources and funding priorities.
- Enhancement of support and funding in the area of forensic science education, training and research.
- Establishment of a *National Forensic Science Fellowship or Scholars Program*.
