¹ For some NSF programs, a PI may self-register.

²For DoD CDMRP, Institutional Administrative Representative does not pre-register. They will automatically be provided a username (individual's e-mail address) and password via e-mail from the system after a PI has submitted proposal information identifying them as the Administrative Representative.

³For awards managed by ONR, can submit text, upload files to satisfy reporting requirements (e.g., final technical reports [FTRs], final property reports, and final patent reports), and submit requests for no funds extensions (NFEs).

⁴ONR initially selected primary point of contact for AdminWeb based upon who had signed the majority of proposals/award agreements for an institution. When AdminWeb was activated, OCGA worked with local ONR to change email address to a centralized one. The same procedure occurred in activating AwardWeb.

⁵Initial award notification is made via email from ONR to centralized email address. PDF Award file is retrieved from a secure web site (access is by UserID and Password). Web site has an acknowledgement feature for successful document retrieval.

⁶ONR AwardWeb can provide award notifications via EDI for those activities with Trading Partner Agreements on file with ONR. See http://www.onr.navy.mil/awardweb/quick_reference.htm for further information

⁷Once the PI has completed the final report, a signed ED Form 524B must be faxed to the Program Office. The ED 524B form requires a signature of the Authorized Representative. The signed ED 524B must be printed and faxed to the Program Office that administers the grant program. A fax number for the Program Office will be provided at the time of submission.

⁸If the PI self-registers and indicates that they can bind the institution in awards, then IIPS will allow registration to be completed. (IIPS Help contacts each potential registrant to determine eligibility to act on behalf of institution.)

⁹PI must download forms for completion outside of the system. AOR then uploads in appropriate volumes.

¹⁰System is currently to be used for the following Office of Justice Programs: Corrections Program Office, Drug Courts Program Office, Executive Office of Weed and Seed, Office for Domestic Preparedness, Violence Against Women Office. The system, with some changes, is also used for the "Gun Violence Prosecution Program Procedures."

¹¹Applicant (at UCLA, PI) provides institutional Authorized Representative information.

¹²This system is a separate application from the Space Telescope Science Institution's Grant Management System.
