- Over \$500 billion annual spending on federal financial assistance
- Decentralized grants management processes & systems




- 9 Lines of Business identified

The Initiative

Government-wide initiative established under Grants Executive Board to support grant-making agencies in meeting goals of Federal Enterprise Architecture

The PMO

Driver of strong grant-making agency collaboration; streamlining & standardizing; and communicating government-wide issues to inform & educate the grants community

The Common Solution

Community driven approach & agency collaboration resulted in a streamlined federal grants management landscape comprised of key agency partnerships: consortia partnerships, alternative solutions group, & strategic partnership group



GMLOB Common Solution Landscape

Consortia Partnership Group

Agencies share best practices & collectively design a consortium solution

Strategic Partnership Group

Partnership between agencies with similar size, mission, & processing volume

Alternative Solutions Group

Agencies granted temporary approval for continued use of an efficient, cost-effective alternative solution

Transitioning Agencies Group

Agencies that have completed key milestones & directives & are entering the planning stage of partnering process


