# OPERA & NIH Organizational Changes

- Introducing Michelle Bulls as Deputy Director, OPERA
- FY2012 Appropriation creates new NIH Center: National Center for Advancing Translations Science (TR) and dissolves NCRR. All active and pending RR grants to be transferred to other NIH ICs. See Guide Notices OD-12-026 and OD-12-027.

# NIH Budget News

- President Obama signed into law H.R. 2055, the Consolidated Appropriations Act, 2012 on December 23, 2011.
  - Appropriates \$30.7 billion to NIH for FY2012
  - Reduces the salary cap to \$179,700 for all NIH grants
    - Now applies to all HHS—not just NIH, AHRQ and SAMSHA as previous
    - Apply Executive Level (EL) II prospectively to all awards that were issued on or after the bill was signed (12/23)
    - Awards issued on or before 12/22, EL-I still applies for FY 2012—only. Future years must be adjusted to reflect EL-II.





# Accelerating Unspent ARRA Awards

- OMB Memorandum M-11-34 Issued 9/15/2011 directs agencies to assure ARRA funds are spent by 9/30/2013 and to “revise the terms of Recovery Act discretionary grant agreements, to the extent permitted by law, to provide for reclamation of funds that remain unspent after September 30, 2013, absent a waiver issued by OMB pursuant to this memorandum.”
- NIH issued on December 13, 2011, Notice OD-12-014, Notice of Revised Term of Award for All Recovery Act Awards to Ensure Project Completion by September 30, 2013. In summary:
  - 1) NIH is revising the terms and conditions on some active Recovery Act awards to amend the current automatic no-cost extension authority by limiting the ability for awardees to extend the final budget period of a project period to no later than 9/30/2013 without prior NIH approval;
  - 2) establishing a procedure for recipients to request prior NIH approval for extensions beyond 9/30/2013; and
  - 3) providing options for those recipients unable to accept the revised terms of award.
- At this time NIH has not determined the need for waiver requests to OMB. NIH continues to strongly encourage grantees to accelerate expenditures for all active Recovery Act grants regardless of the current or projected project period end date.

  - CWG pilot implementation: Now planned for April 2012
  - Anticipate expanding pilot to all FDP organizations in late July if pilot goes smoothly.

  - Administrative Supplements (Type 3 applications): Pilot to begin 2/1/2012; See Guide Notice [OD-12-024](#)
  - Change of Grantee Institution (Type 7 applications)—pilot now April 2012
