Development of NIH RPPR

- **Implementation Plan Jan 2011; updated Jan 2012**
 - **Commitment to electronic format**
 - **Pilot in Spring 2012**
 - **RPPR to replace all other interim progress reports**
 - **AHRQ, FDA and CDC partners**
- **NIH RPPR Workgroup**
 - **Policy co-chairs; representatives from program, grants management, eRA, and agency partners**
- **Multiple consultations with various functional committees and subject matter experts (e.g., international activities, public access, training programs, SBIR/STTR, etc.)**
- **Consultation with Commons Working Group**
- **Federal-wide Data Dictionary effort**

Guiding Principles

- **Embrace spirit of RPPR**
- **Minimize collection of new information**
- **Maintain collection of information that is scientifically and administratively needed to monitor awards or required for reporting purposes**
- **Eliminate collection of information that is not needed or is not used**
- **Minimize impact on NIH grantees**

eRA RPPR Module

- **8 screens, one for each component**
 - A. Cover Page
 - B. Accomplishments
 - C. Products
 - D. Participants
 - E. Impact
 - F. Changes
 - G. Special (NIH) Reporting Requirements
 - H. Budget – SF424 (R&R) forms
- **Pre-populates data where possible**
- **Uses check boxes, including *Nothing to Report*, text entry, and PDF uploads**
- **Indicates Agency specific instructions with:**



7 Types of RPPR: Examples of Differences

R01-like	<ul style="list-style-type: none">•Standard RPG•Basis for development of other types
Individual CDA	<ul style="list-style-type: none">•Mentor report•RCR reporting
Training	<ul style="list-style-type: none">•Trainee Diversity Report•RCR reporting•Tables 12A/B & program statistics, if applicable
Fellowship	<ul style="list-style-type: none">•Sponsor comments•RCR reporting
Education (e.g., R13, R15, T36)	<ul style="list-style-type: none">•No reporting on technology or invention products, resource sharing, impact on infrastructure, tech transfer
SBIR/STTR	<ul style="list-style-type: none">•Report on technology transfer, product development status, and commercialization plan
Complex	<ul style="list-style-type: none">•Parent reporting similar to R01-like•Project/core (s) reporting on accomplishments, technologies, products, resource sharing, publications, hESCs, human subjects

Business Process Changes

- Collect new information on foreign activities
- Enhance publication reporting
 - Progress Report Additional Materials (PRAM)
- Streamline ClinicalTrials.gov reporting
- Clarify use for prior approval requests
 - Only for significant reduction in LOE of personnel named on NoA
- Apply SNAP questions to all progress reports
- Changes to participant information collection
 - rounded effort
 - foreign affiliation

RPPR Pilot Spring 2012

- Solicited participants from CWG Oct 2011
- 7 volunteer grantee organizations
 - Duke University
 - University Michigan
 - Oregon Health and Sciences University
 - Univ of Calif, Los Angeles
 - Univ of Calif, San Francisco
 - Rush University Med Center
 - University of Washington
- Held training session and posted resource materials
- Allowed 2 week grace period for progress report deadlines
- Use of RPPR module OPTIONAL
- Encouraged immediate feedback
 - Critical errors fixed in out-of-cycle, June eRA release
- Held July feedback discussion

FDP Early Access

- After consultation with FDP Executive Director, NIH provided FDP institutions with early access in the spirit of collaboration.
 - Allows FDP institutions to begin training investigators and research administration staff
 - Provides FDP institutions with experience with the system before it is available to all NIH grantees
- RPPR Module OPTIONAL for FDP institutions
- June 18 training webinar for FDP; archived on FDP website

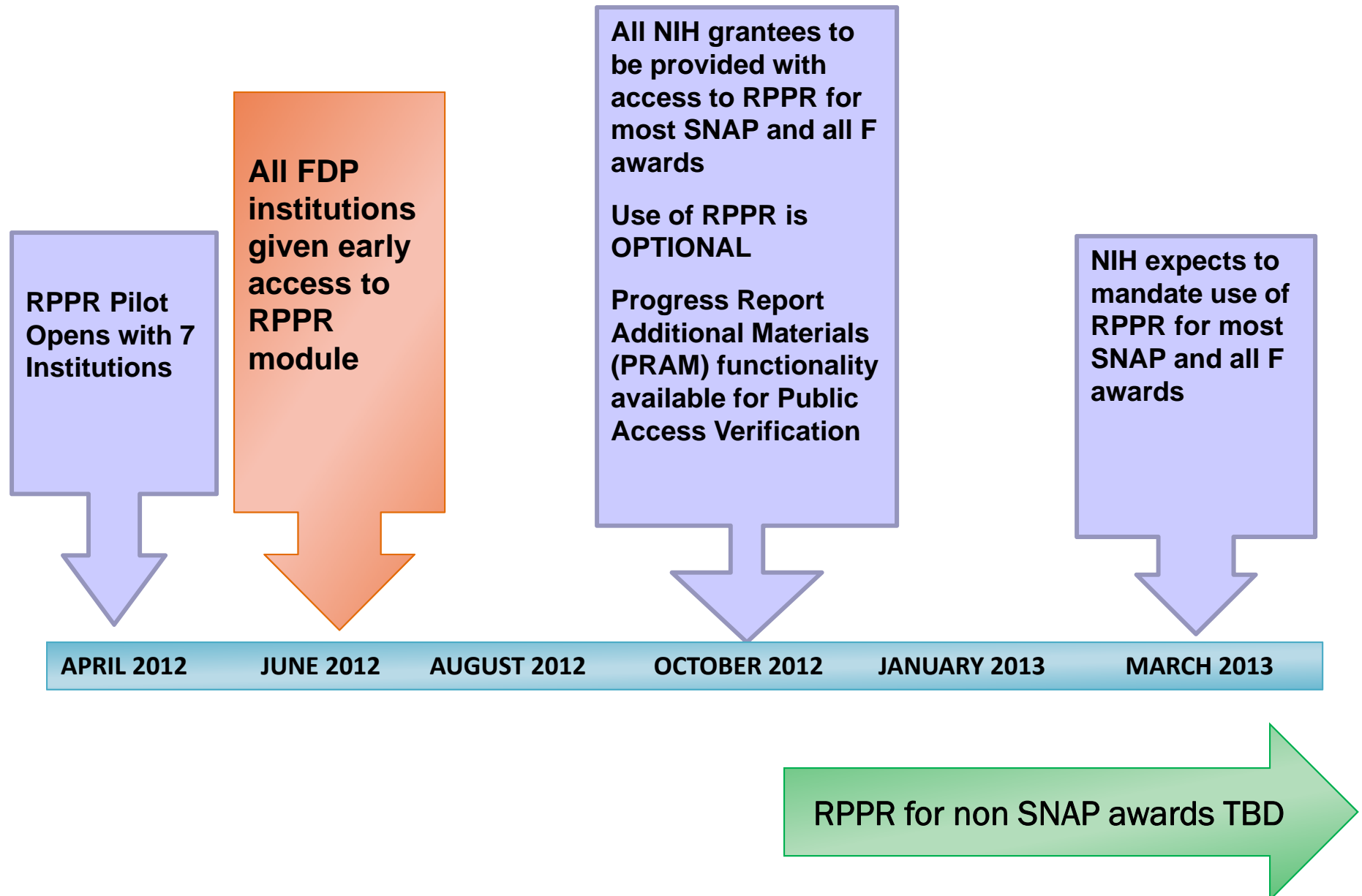
Positive Feedback

- **Layout, flow, and functionality are logical and intuitive**
- **Auto-population improves efficiency**
 - **Publications from My NCBI accounts**
 - **Personnel data from Commons Profiles**
 - **Data from previous reports**
- **Facilitates administrative review**
- **Straight-forward and easy to use**

Suggestions for Improvement

- **System-to-system submission**
- **Auto-save feature rather than pop-up reminder**
- **Clarify instructions for specific sections**
- **Default performance site to site in application rather than Commons institutional profile**
- **Special characters should be supported as text entry (currently only supported in PDF uploads)**
- **Allow decimals in person months rather than rounding to nearest whole person month**
