What happened to CRIS?

- REEport Replaces CRIS Web Forms, which was the data collection software run by the University of Vermont.
- The “CRIS Database” and its associated search tool still exist for running data queries and reporting needs.

 - Internal Database > REEport (non-capacity grants entered through grants.gov)
 - Multistate Research Projects from NIMSS
- Functionality Fixes
 - Access to non-capacity grants
 - User Roles

Areas for Improvement

- Capacity/Formula:
 - Project change process is burdensome
 - Cannot back-date the start date
 - Multistate Projects from NIMSS not available
 - Wrong DUNS #
 - Wrong site address
 - No ability to create or define roles

Areas for Improvement

- Non-Capacity/Non-Formula

(Incl. Competitive)

- “Site” Assignment Process
- Process to update data imported from grants.gov is laborious.
 - Updated data not transferring correctly
- Only PD or SA can edit project; AOR has read only rights (role definition problem)
- No ability to edit prepopulated fields
- Inability to submit Final Reports for older grants

Internal Staff Education

- Training at NIFA will help educate staff on system functionality
- Will also create awareness about CRIS-REEport transition issues that affect data (and project approvals)
- More educated staff means questions will be more easily/quickly answered.

- Financial Report
 - For FY13 reporting, still done via AD-419 using CRIS Web Forms

New & Upcoming Funding Opportunities - September

- Higher Education Challenge
 - all colleges that have food and ag science programs eligible
 - note 25% match required
- Secondary and 2-Year Postsecondary
 - higher education institutions eligible
 - note 25% match

Upcoming Funding Opportunities – Sept (cont)

- NIFA Fellows
 - last year about \$6 million
 - supports pre and post doctoral students
- Specialty Crops Research Initiative
 - funding for this is still unclear pending farm bill

Upcoming Funding Opportunities – October

- Biotechnology Risk Assessment
 - about \$4 million last year
- Agricultural Food & Research Initiative (AFRI) Foundational
 - supports research grants in 6 priority areas to build foundation of knowledge critical for solving current and future societal challenges

Upcoming Funding Opportunities – November

- Joint Plant Feedstock
 - Joint with Department of Energy
 - supports genomics-based research that will lead to improved use of biomass and plant feed stocks for production of fuels such as ethanol or renewable chemical feedstocks
 - Preapplication requested
