# FDP - Phase VI 2014-2020

## Mission

- The Federal Demonstration Partnership (FDP) is an association of federal agencies, academic research institutions... and research policy organizations that work to streamline the administration of federally sponsored research. ... The goal of improving the productivity of research without compromising its stewardship has benefits for the entire nation.
- The FDP uniquely offers a forum for individuals from universities and nonprofits to work collaboratively with federal agency officials to improve the national research enterprise. At its regular meetings, faculty and administrators talk face-to-face with decision-makers from agencies that sponsor and regulate research. They... test the new ways of doing things in the real world before putting them into effect.

# FDP - Phase VI 2014-2020

  - Electronic Research Administration

# FDP - Phase VI 2014-2020

***Researchers doing science, not administration***

- Results of 2012 Faculty Workload Survey
  - Once again, PIs estimated 42% of their research time was spent on meeting requirements rather than on active research.
    - 15.4 % Proposal preparation
    - 13.6% Post-award administration
    - 7.6% Report preparation
    - 5.7% Pre-award administration
  - 23 different pre- and post-award administration responsibilities identified.
  - Researchers reported an average of 8.67 different administrative responsibilities within one-year.



# FDP - Phase VI 2014-2020

***Researchers doing science, not administration***

- Results of 2012 Faculty Workload Survey
  - We can use the survey results to identify burdensome regulations, policies and procedures to address.
  - There are limitations to this approach.
    - Sources of burden are numerous and diverse.
    - Improvements have not kept up with new regulations and requirements.
