## FAQ Highlights

- Non-FDP members: Makes clear cannot revise templates, or must remove FDP moniker if they do.
- Strongly discourages the use of Attachment 2 for generic imposition of additional terms like choice of law, insurance requirements, and indemnification.
- New FAQ sections on Unilateral/Bilateral Mods, and Copyright.
  - Added to template language: "Subrecipient grants to PTE the right to use any written progress reports and deliverables created under this Subaward solely for the purpose of and only to the extent required to meet PTE's obligations to the Federal Government under its Federal Award."

#### Carryover Guidance

- Draft Guidance document released August 15
  - Included summary of May survey results
  - Also included unilateral mod templates to highlight modification language options
- Survey Monkey used to gather comments
