HAVA - The Law

Each state, acting through its chief state election official, shall implement, in a uniform and nondiscriminatory manner, a single, uniform, official, centralized, interactive, computerized, statewide voter registration list defined, maintained and administered at the state level. Public Law 107-252, Title III, Sec. 303(a)

Background

What does HAVA mean for KS? Single database hosted and managed at the state level, data maintained by the counties – "Top down" **105** counties 14 different VR / EM systems in use Limited resources

Approach

Requirements set by county workgroup 7 counties; state ELM, IT, legal, consultant Voter registration, election management poll worker, polling place, petitions, imaging, barcode voting history update / mailings RFP process: Election Systems & Software (ES&S) PPEE (ELVIS), Voterview, iPowerProfile Alabama, Arizona, Arkansas, Nebraska, New Mexico Built for 600 total users, 510 county users 5 years maintenance, help desk HAVA requirements implemented 12/2005 KDOR (DMV), KDOC, KDHE

Challenges

- Time and resources
 - County workgroup, steering committee, KS PM, vendor management, deliverables based fixed price contract
 - Connectivity
 - Availability, maintenance, security KANWIN, required router and circuit upgrades
- Conversion
 - 105 county data sets, establishing agreed upon standards, mappings, clean-up
 - Security
 - Central system, all registration records in one place
- Availability
 - Fully redundant primary site, D/R site
- Training
 - Initial, ongoing releases, refreshers
 - Regional classroom, webex
- Partnerships/communication are key

External Interfaces

- All interfaces handled through system application, Agency Central
- KDHE death records
 - Manual download and load into AC database, instant check against new/changed registrant records, batch run against VR database

KDOC – felon records

 Automated download and load into AC database, instant check against new/changed registrant records, batch run against VR database

External Interfaces Cont.,

■KDOR (DMV) – DL/SSN

- Real time web service call on new/changed registrant records w/DL, DMV perform SSA check
- KSOS set-up & monitoring of jobs
- Counties notified via email, reports from batch jobs
- Counties presented with potential matches from interfaces, responsible for further research and decision on match

ELVIS PKI

- Securing statewide application
- Vetting of identity
- Authentication two factor
- Requirements
 - Leverage state PKI infrastructure must have KS PKI certificate to "see" ELVIS system
 - Portability for county election office front counter, temporary workers

ELVIS PKI Implementation

- Vetting contracts between SOS, counties
 - Verisign USB Token Based system
 - Portability
 - Certificate private key not exportable from token
 - PIN for two factor authentication
 - Uses additional certificate field, must be same as in active directory




- Lessons Learned
 - "Technical" process, must follow instructions EXACTLY
 - Software on workstation
 - Token lifecycle forgotten PIN, distribution, temp workers
