 - Policy agenda developed by broad coalition of national organizations, state leaders and technical experts across education/workforce spectrum

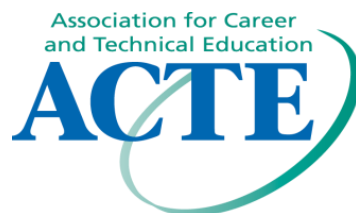

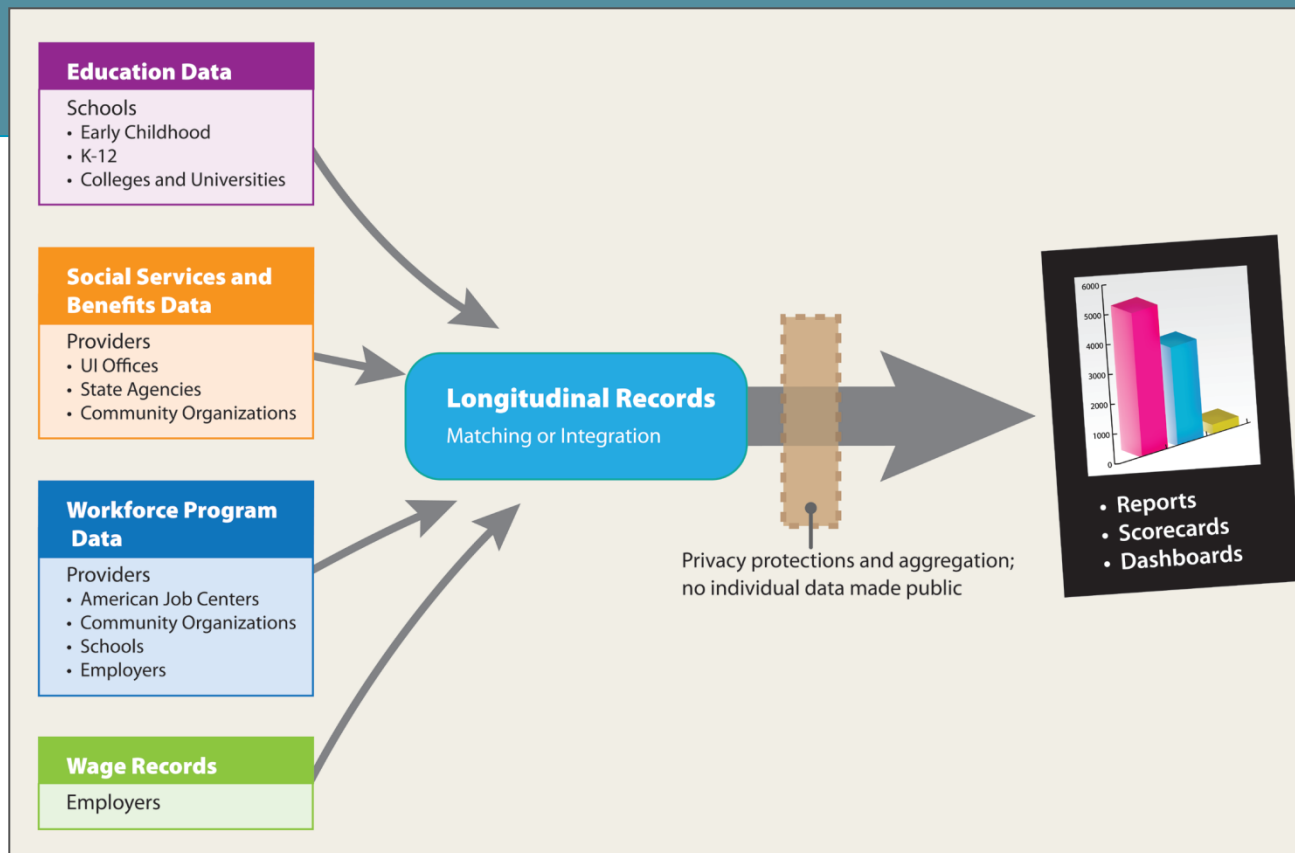

Uses of State Data Systems

- Measuring Outcomes
 - Minnesota Graduate Outcomes Tool
- Evaluating Program Impact
 - Washington reports to legislature
 - Kentucky workforce board partnership
 - Arkansas career pathways evaluation
- Supply/Demand Analysis
 - Ohio teacher report

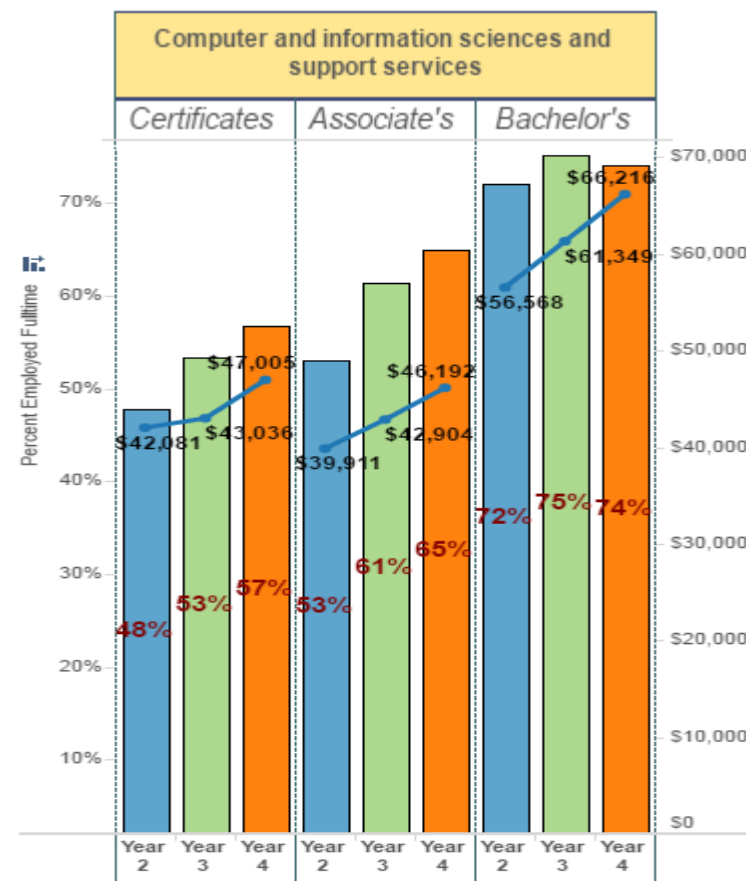
State Blueprint: Assessing Employment Outcomes

- Higher Education Act reauthorization



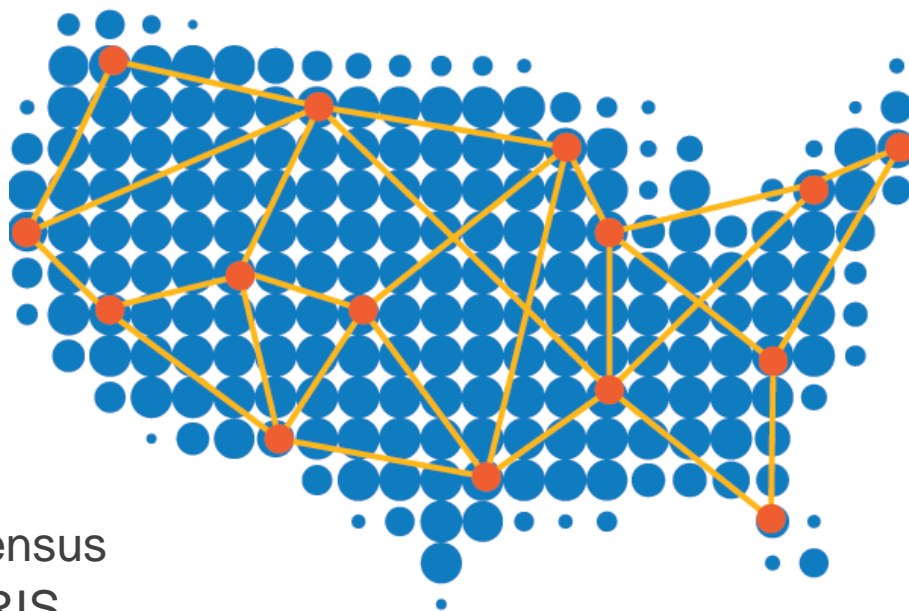
State Blueprint: Cross-State Data Sharing

- Use of WRIS2 for colleges
- Regional data sharing
 - WICHE, Western states

Federal Developments

- 2017 Budget: NDNH access
- Use of tax data from SSA and/or Census
- DOL commitment to renegotiate WRIS

- Pilots: CompTIA; Workforce Credentials Coalition
- Partnership with Nat'l Student Clearinghouse
