# Operational Data Benefits


- Utilizes existing systems and processes
- Continually updated
- Scalability
- May reflect broader geographic reach
- Provides insight into who is gaining assistance and efficacy of identification efforts
- Can inform the design of academic research studies

# Operational Data Collection Challenges

- Reflective of awareness/access to support – Not prevalence
- Byproduct of another primary function
- Ethical issues surrounding information as a requirement to access assistance
- Strict definitions are not always relevant to response
- Data use and informed consent questions
- Processed insight vs. Info. attained during time of acute stress

# CTDC Founding Ethos

- Privacy of data subjects is #1 priority
- Don't let the perfect be the enemy of the good
- Organizations with data need to drive the effort
- Increase in data contributors help include populations traditionally excluded
- Full transparency over limitations of data
- “Crowdsourcing” analysis yields greater impact
- “Big Data” mindset (if not yet reality)



# Merging Datasets

## POLARIS DATA

- PREVIOUSLY focused on “case records”  
*(Individual victim records since 1/1/2015)*
- US legal definitions
- Reported through crisis hotline  
*(Assessments made but no standardized questions asked)*

## IOM DATA

- Based on “victim records”
- International definitions
- Reported through client interviews

- 172 Countries of Exploitation


# Two Primary Outputs

## 1. K-anonymized, disaggregate data for download

- Full codebook with information about data collection and standards available
- Data includes:

Demographics	Trafficking Context
Gender	Type of Trafficking
Age at Start of Exploitation	Industry of Exploitation
Age at Time of Contact with Agency	Means of Control
Citizenship	Country of Exploitation
Primary Language	Relationship to Recruiter
