
Dear Charlotte and Jim:

**Anticipated Date of Submission of Proposals to Sponsors:** Proposals have been sent and were funded by the Andrew W. Mellon Foundation, the Alfred P. Sloan Foundation, the National Institutes of Health, and the National Science Foundation. A proposal is pending at the Department of Energy, and a proposal will be sent the United States Department of Agriculture in July 2006.

**Other IRBs** that will review this protocol, if any: Some universities may also wish to review the questionnaires and have them approved by their IRB Office

**Detailed Research Protocol** (may be provided in an attached file):

This is an addendum to the earlier request for IRB review of the Faculty Survey.

The Faculty Questionnaire has been distributed in electronic format and faculty are completing the instrument and sending it to the contractor, Mathematical Policy Research. On a few occasions faculty members had requested changes to their responses and have asked that new data be included. The contractor has opened some of the individual files for the corrections, but has found that it is more convenient to open all file and tell individuals who inquire that their file is open and they can make changes in survey information. This is a change in the procedures for the survey and we request that it be added to the approved protocol.

**Explanation of Reason for Selecting the Indicated Category of Research:** In the Assessment of Research-Doctorate Programs human subjects participate by completing a series of voluntary questionnaires.
