Description: As part of the national emphasis on bringing transparency to the decisions and actions of government, Federal policy communities are considering a process to examine and analyze the benefits and outcomes from Federal research assistance. Unlike prior efforts looking predominantly at direct impacts such as papers and patents, this effort will look at the cascade of benefits and impacts by going deeper and wider into the value chains such as employment, contracts, purchases, intellectual property exchanges and new company start-up. In order to discover all necessary elements and close any gaps in such a process, a pilot has been designed and this presentation will preview the pilot and discuss the goals of the overall effort.
