### MINUTES    Commission B Business meeting

National Radio Science Meeting  
Boulder, CO  
January 9, 2002

1. Chair P. L. E. Uslenghi called the meeting to order at 18:00 hrs. He welcomed all members and guests. Attendance list is provided at the end of the minutes.
2. The minutes of the July 9, 2001 meeting of Commission B held at Boston, MA were approved.

### Committee Reports

3. R. Pogorzelski, Chair of the Membership Committee presented the committee report. The committee members are J. W. Mink, R. E. Collin, S. L. Dvorak and D. Wilton.
  - There were two nominations for Full Membership. Prof. A Yakovlev (University of Mississippi) and Prof. P. Wahid (University of Central Florida). After some discussion, both nominations were approved by a voice vote.
4. D. Jackson presented the Technical Activities Committee report. The Committee members for 2000-2003 term are: N. Engheta; J. T. Johnson; T. K. Sarkar; J. T. Williams; and D. H. Y. Yang.
  - A summary of the Commission B session and joint sessions involving Commission B at the 2002 Boulder meeting was presented. There were a total of 38 sessions at the symposium; of these 7 were URSI B sessions and 1 joint session with URSI A/B/D. The details of Special Sessions involving URSI B, with organizers in parenthesis, are as follows:

6. P. Uslenghi discussed the Maastricht General Assembly at length. Deadlines for submission of one to four page summary and the deadline and format for the final paper were noted. Commission B has been allotted 34 slots of the total 120 delegates at General Assembly who will receive a stipend of about \$800.00. The large number is because of our members' high participation at the business meetings and a large number of papers presented. This number is exclusive of officers. Uslenghi will send out an e-mail about this.
7. P. Uslenghi informed the members that USNC will submit a US proposal for 2005 or 2008 General Assembly and has selected Denver as the site.
8. Ross Stone is looking for Associate Editors for Radio Science Bulletin.
9. A flier (published in Radio Science and AP Magazine) announcing the URSI Commission B International Electromagnetics Prize was distributed.
10. A new Vice-chair for International Commission B will be elected at the General Assembly; It was felt that US would not present a candidate.

### Action Items

11. Ad Hoc Committee presented pros and cons of the National Radio Science (January, Boulder) meeting. After some discussion a show of hands indicated the members' sentiment to keep the meeting in Boulder.
12. Sponsorship/participation of URSI (Commission B) in Topical Meetings such as on Wireless Science, Technology and Application in Hawaii (2003) was discussed. There was lengthy discussion. A show of hands indicated a favorable response (with one opposed)
13. Volunteers are needed for General Assembly in Denver proposal preparation. Let Uslenghi know as soon as possible.
14. Nominees for USNC-URSI members-at-large are needed. Members unanimously recommended D. Wilton and M. Piket-May to USNC.

**15.** USNC has noted that there is a lack of young blood entering URSI. The chair made two suggestions. (a) Create a category called 'Student Member' (requirements: Attend one URSI meeting; membership for 3 years and may be renewed if still a student and comes to another meeting during that period). Members were in favor of this suggestion. (b) Contingent on availability of funds – recommend some form of financial support to encourage student attendance. Members were generally in favor of supporting the 10 participants of the student paper contest.

**16.** Submission format for URSI meetings was discussed. The issue of 1 page vs. 1-4 page abstract was discussed. The latter requirement at the General Assembly was noted. After considerable discussion, the vote indicated 15 in favor of 1 page, 4 in favor of a fixed length and none in favor of flexible abstract submission. A primary concern of the members was that a flexible length will evolve into a four page summary for all submissions.

**17.** Uslenghi discussed the need to elect a Vice-Chair for the Commission B for the triennium '03-'05. Pogorzelski will take over as the Chair of Commission B after the General Assembly, and officially beginning January 2003. A selection committee for nomination for Vice-Chair consisting of the present chair (Uslenghi), past chair (Wilton) and incoming chair (Pogorzelski) has nominated two candidates based on their commitment, perceived ability to conduct Commission B business and the need to bring in young blood. The two nominees are: Prof. David Jackson and Prof. John Volakis. Election will be held via e-mail at the end of February.
