The meeting will examine the asymmetrical globalization of American research institutions (academic, industrial, and governmental). The rapid global engagement of all three sectors in GUIRR, carried out in an inconsistent way, has created tensions in the US research enterprise that need to be fully diagnosed and understood to create a new era of US leadership and prosperity. These global initiatives often take the form of partnerships between US and foreign institutions, although not always within the same sector (e.g., a private US university with a foreign state-managed university). The traditional backbone of international relations – the US government – has played a limited role in identifying and managing the ramifications of these partnerships. The recent issuance of the NSB report on international activities raised some long-term questions; there is also active congressional interest in reforming the US government role in international science and technology policy.

The next GUIRR meeting will seek to nail down what we know and where we need additional research to understand the strategies and goals of each sector. We plan to have representatives from corporations and universities describe their partnerships with foreign institutions, and allow the GUIRR members to discuss the relative benefits of each approach.
